

## St. Mary's Academy 2011-2012 Tuition Payment Plan Schedule

A portion of tuition may be considered a charitable donation.

As the donation portion of the tuition is based on our religious expenses for the entire school year **and** we have a refund policy, we calculate the charitable donation portion of the tuition at the end of the school year. As such, receipts for the 2011-2012 school year will be issued with a date of December 31, 2012 **even if tuition is fully paid in 2011**. The receipt will be mailed to you in January 2013 for use on your 2012 tax return.

Receipts can only be issued to the party who actually made the payments. For example, if we receive a cheque for tuition from ABC Company, ABC Company will receive the donation receipt. If we receive a cheque from a trust, the trust will receive the donation receipt.

4	If you are choosing Plan A or B and are choosing to pay by post-dated cheques, please make all cheques payable to St. Mary's Academy and write your SMA account number in the memo area of each cheque.  If your cheques are not personalized, print your name, address and telephone number on the top left hand corner of each cheque.  Please double check post-dated cheques for accuracy (e.g. 2012 where applicable).
5	If you will be applying for a bursary, you must pay by preauthorized payments. The non-refundable deposit is due at this time and will be withdrawn from your account on or after April 1, 2011.
